By clicking the acceptance “I agree” you are agreeing to accept the term and conditions as laid down hereunder. “**fixmytax**” is an IPR of Dr. Pawan Jaiswal; Promoter & Founder Karsathi Consultants Private Limited a web-based / app-based portal for providing a one stop platform for all intricacies related to taxation.

It is to be appreciated that the agreement between “fixmytax” / KARSATHI CONSULTANTS PRIVATE LIMITED [KCPL] is governed by Section 2(a) of the Indian Contract Act, 1872 where in the user signifies his willingness to obtain services from “fixmytax” / KCPL with a view to obtain assent from “fixmytax” / KCPL as if he is making proposal whose approval is sole discretion of “fixmytax” / KCPL.

4. "fixmytax" Any Other Services related to afore-said at 1 to 3 and any other related "**fixmytax**" service or other service that you select, pay for or use in connection with "**fixmytax**" tax preparation products and services, or other related services provided by "**fixmytax**".

1. License and Permitted Use:

According to the terms and conditions of this Agreement and the payment of all the requisite fees; KCPL grants to you a restricted, personal, non-transferable right to use the services for preparation of replies to your Notices of Income Tax / GST; preparation of First Appeal, preparation of Second Appeal and use the portal "fixmytax" to prepare and electronically file ("e-file") your tax returns. It is to be appreciated that your usage for services of "fixmytax" may require payment of additional fee if needed as per your further requirement of service. This Agreement permits you to access and use of the services only in the manner set forth herein for which you have paid requisite fees. You may avail the services

through KCPLs' online service available at <https://www.fixmytax.in> or any other approved third-party website as KCPL may direct. By entering into this Agreement, you hereby agree that you will not use the services in connection with providing tax advice or to provide any other services to any other party [except only in case of Platinum Membership of the Portal]. It is the responsibility of the user to take hard copy of the Replies / Written Submissions / Tax Returns filed for their future references; “fixmytax” / KCPL shall in no manner be responsible for retrieving such details / data from the Tax Portal (Income Tax & GST).
